Secretary's report

The trustees of the Tartan Army Children's Charity have the pleasure of presenting their Annual report and the audited financial statements for the year ended 31st March 2010.

The charity complies with the 'charity test' and is a registered Scottish charity with the Office of the Scottish charity regulator with the registration number SCO38330. The charity is governed by a constitution as amended May 2009.

Business review and future strategic objectives

The 12 month period up to March 2010 has seen a great deal of expansion by TACC in terms of growing our fundraising channels in addition to focussing and expanding our objectives. It has been an exciting period with a number of ideas generated and implemented that have proven successful and will continue to provide a valuable source of fundraising revenue in the future. Brief details of the activities undertaken in 2009/10 are presented below.

During this period our main fundraising focus was the "TACC South Africa 2010" campaign which coincided with the World Cup qualifying campaign and pledged to support disadvantaged children in South Africa during the 2010 World Cup Finals. The Oxfam run 'Let us grow' program was chosen as the initial project to receive TACC support. The fundraising campaign was well received and up to the end of the World cup qualifying campaign in October 2009 we raised a fantastic £60,000, £25,570 of which related directly to Let us grow. We decided to donate to two projects in South Africa, the 'Let us grow' in Johannesburg and 'Umthombo Street children' in Durban. The actual grants will fall into the 2010/11 report but it's relevant to mention in terms of both our fundraising activity and the balance carried forward at year end.

Our successful and popular annual Charity Ball was held at the Balmoral Hotel and raised £21,500 through ticket sales, auction and a single donation matching the amount raised on the night.

Our Christmas present appeal for children supported by Aberlour Child Care Trust was twice as successful as the previous year, with £4,250 donated by supporters. TACC matched that to donate £8,500 in total, used to provide Christmas presents for disadvantaged children throughout Scotland.

TACC did not donate at any Scotland away matches in the period, having made a large donation in Macedonia in September 2008. Following the World cup qualifying campaign and the £60,000 raised for the South African projects the Management Committee agreed to change policy in order to make a donation at any appropriate away match in the future, rather than our previous strategy of one large donation per campaign.



The first TACC Kiltwalk (which took place in April 2010) was launched during 2009/10, with over 500 people registering. The income report includes £12,000 sponsorship already raised online by 31st March and £8,000 relating to registration fees.

The TACC Lottery has continued to be a regular revenue stream with over £6,000 realised in the 2009/10 period. We refreshed the marketing push for the lottery and offered additional monthly incentives including signed football strips and tickets to Scotland matches to increase participation. This is a valuable and well received fundraising stream and we intend to continue the lottery and additional incentive strategy over the next 12 months.
